ORDER

Vide paper read 1, affiliation and recognition of institutions imparting education in Engineering, Technology and Management in Kerala is vested with APJ Abdul Kalam Technological University (APJAKTU) Accordingly, vide paper read 2 above, Government of Kerala made affiliation of institutions which impart education in Engineering and Technology in the State of Kerala with APJAKTU as mandatory from the academic year 2015-16 onwards.

In accordance with the above, vide paper 3, Syndicate at its meeting held on 04.02.2020 has resolved to entrust Hon'ble Vice Chancellor to prepare a time schedule for inviting application for the affiliation of institutions for the AY 2020-21 and further processing by incorporating the norms as per the Approval Process Hand book 2020-21 of AICTE.

Accordingly, Hon'ble Vice Chancellor has issued orders to follow the schedule and the fee structure given below and issued notification, vide paper read as 4, in connection with the Affiliation process for the Academic Year 2020-21. Orders have also been issued to obtain financial guarantee from all the institutions, since the institutions are now affiliated to APJ Abdul Kalam Technological University only.

Vide paper read 5, Government has directed for a lock down in the state except for the institution offering essential service to the public. Considering the situation and to adhere to the guidelines fixed by the government in this regard, Hon'ble Vice Chancellor has accorded sanction to extend the dates for the submission of online application for affiliation for the AY 2020-21 as follows;



Last Date of submission of Online Application	17.04.2020
Last Date of submission with Fine	22.04.2020

Other conditions stipulated in the notification, vide paper 4, remains as such.
