In accordance with Chapter VIII of the APJ Abdul Kalam Technological University Act, APJAKTU invites application for affiliation of “Existing and New Technical Institutions” of the State which conducts Under Graduate and Post Graduate programmes in Engineering and Technology, MBA, MCA and Architecture for the Academic Year 2020-21.

The online applications will be available in the e-Gov platform of the University in the URL www.ktu.edu.in from 12th of March 2020. New institutions are requested to register for User ID and Password through the platform by remitting a fee of ₹5000/- (Rupees Five Thousand only) by means of online transaction to access the application form and the currently affiliated institutions can use their existing User id and password. The duly filled applications can be submitted online by paying the required processing fee through e-payment gateway till 1st of April 2020.

The process of affiliation of programmes to APJAKTU shall be based on the norms and standards specified in the Approval Process Hand Book 2020-21 of AICTE and based on norms and guidelines issued by APJAKTU from time to time. There is no need to submit the hard copy of application except the “Affidavit-1” in the prescribed format in Kerala Govt. stamp paper of value ₹500/-. (Format attached).

The Institutions will have to remit an amount towards Financial Guarantee at the rate mentioned in the Fee Details shown below.
